- SIREUS 2.0 Evaluation
 - "SIREUS Summary after 2 years" (document)
 - Evaluation team is selected and have agreed to participate
 - January 8th Document sent out to the Evaluation Team
 - January 31st 1st virtual meeting (Teams) @ 15.00 CET "Deciding on the key topics."
 - February 28th In-person meeting in Stockholm (@SU) 10:00 16:00 CET
 - "Deciding on recommendations on the way forward."
 - March 7th 2nd virtual meeting (Teams) @ 15.00 CET "Review of recommendations."
 - April 9th 3rd virtual meeting (Teams) @ 15.00 CET "Agree on the recommendations."
 - April 16th Steering Committee should discuss the recommendations.
 - May 8th 4th virtual meeting (Teams) @ 15.00 CET "Feedback after SC meeting."
 - May 28th Steering Committee make decision on recommendations to the Stakeholders Group

"SIREUS – Summary after 2 years"

Document distributed to Evaluation Team on January 8th, 2024, and to Steering Committee on January 10th, 2024.

Minutes from meeting with Evaluation Team (SU Feb 28, 2024)

Document distributed to Evaluation Team on March 11th, 2024, and to Steering Committee on April 12th, 2024.

- SIREUS Platform to ambitious for the resources allocated at universities
- Lack of government funding => not sustainable operation
- Difficult to satisfy all => workgroup participation is not always highest priority
 - Larger vs. smaller universities
 - Focus on Talent Mobility vs Innovation/Research
 - Different universities have different maturity for their US Strategy

Recommendation from Evaluation Team

- SIREUS 2.0 More focused, fewer meetings, focus on events and open up the network. > ~10 universities needs to join to form a network.
- 2. Only focus on Study-in-Sweden events. Not enough substance to have a network. SACC does not see it as strategic and would probably not be involved.
- 3. SIREUS will end after January 31st, 2025.

 - Affiliated Company Members
- Non-members can purchase activity participation (test already 2024)
- Increase the SIREUS brand and activities
- Adequate funding for the mission



SIREUS 2.0 Decisions

- Plan & Structure
 - SIREUS Stakeholders have to decide on best way forward
 - SACC USA have to decide if willing to take on the extension
- Vinnova, VR, SI and other organizations is positive to the focused approach and events
- Sentiments from affiliated universities and companies are there
- Budget will be a challenge
- Decisions
 - Who (SIREUS Members) are willing to sign up for the extension
 - Can we invite other universities / institutions to be part
 - Can we sell activities outside of the member base
 - Decision <u>before</u> the May 28th meeting.
 - Interactions in order to build a viable transition plan
 - Special executive working group decision August meeting.
